What is poverty?

Absolute, poverty lines

- **SDG target 1.1**
 - By 2030, eradicate extreme poverty for all people everywhere, currently measured as people living on less than \$1.25 a day
- **Global declining *but rising inequality***
- **Relative (time, place, within & across societies, inequalities)**
- **Multidimensional**
 - **SDG Goal 1: ending poverty *in all its forms***
 - **Target 1.2: By 2030, reduce at least by half the proportion of men, women and children of all ages living in *poverty in all its dimensions according to national definitions.***

Some core dimensions

- Income
- Housing
- Education
- Food
- Energy
- Health & well-being
- Cumulative <-> capabilities
 - Indices (Nolan, Whelan et al, Alkire & Foster)
 - Severity, poverty gaps, **inequalities & the non-poor**
 - Overlaps



Ending housing deprivation, extreme poor (50%), EU

1) Anti-poverty strategies

- Social welfare
- Employment
- housing allowances

Ending housing deprivation,
'*extreme poor*' EU:
2) affordable housing provision

- 'Burdensome' housing costs, 57%
 - High 88% (Croatia)
 - Low 15% (Sweden)
- *Highest spending priority*
- *Then energy*
- *Then food*

- Overcrowding, 33%
 - High 66% (Romania), Low 5% (Cyprus, Ireland)
 - “My husband and I live with my son, his wife & five kids & my youngest child in a 2 bed apartment. We have been living here for 6 years. I sleep in the living room on the floor, in the same room is the kitchen, the dining room, sitting room and bedroom” (Roma, Ireland).
- Fear of rough sleeping public spaces

Ending housing deprivation, extreme poor:

3) sustainable housing renewal programmes & building regs

- Damp & rot, 26%
- High 57% (Hungary)
 - Low 8% (Finland)
- Lack indoor toilet &/bath/shower for sole use of household, 14%
 - High 73% (Romania)
 - Low 1% (Ireland)

Roma housing themes

- Rats
- Open sewers
- Abandoned warehouses
- Overcrowding



Ending housing deprivation:

4) Anti-discrimination & anti-racism strategies

- Incl. institutional (e.g. HRC, right to reside, housing & welfare policies)
 - Especially ethnic minorities (e.g. Travellers, asylum seekers)
 - Migration & life-course
 - Roma: evictions/burnt out, expulsions -> journey through Europe, 'end of the line'?, severe housing deprivation in Ireland

“We live at the moment in a house with no electricity, no gas and no facilities” (Roma, Ireland).

Promising avenues for interdisciplinary research?

- Energy poverty
 - Residential
 - Transport
- Disaster risk reduction & poor households
 - Storm damage, energy, flooding, coastal erosion...
 - No insurance, no savings, no bank a/c
- Food poverty
- **Critical of SDGs & indicators**
 - **Practices of non-poor & inequalities**
 - **Housing affluence, over-consumption & vacancies**
 - **Development model (growth & consumption)?**
