INTRODUCTION AND OVERVIEW

OVERVIEW

The UCD Geary Institute for Public Policy is a recognised centre for research that is relevant to policy, theoretically informed, and empirically based. The Institute promotes empirical research in the social and behavioural sciences and convenes researchers to foster discourse on theories, techniques, and empirical findings. The primary fields of study at Geary encompass demographics, economics, education, environmental policy, law, political science, psychology, public health, social policy, and sociology. The Institute enhances and broadens the fundamental research proficiency of UCD Schools and Institutes, integrated with both international and national collaborations.

VISION

The Geary Institute for Public Policy aims to lead in policy-relevant, empirically based research within the social and behavioural sciences at UCD and across Ireland, focussing on the intersection of academic research and public policymaking implementation. Our vision is to establish a platform of excellence for examining issues pertinent to policy discourse and decision-making. This vision is actualised through the three pillars of People, Papers, and Policy. The Geary network of research fellows exemplifies rigorous excellence, producing cuttingedge research via working papers and peer-reviewed publications that inform policy innovation and development.

MISSION

By disseminating high-quality empirical research to inform important academic and policy debates, we hope to support policy-relevant research in the empirical social and behavioural sciences, bring researchers together to foster discussion on theories, methodologies, and empirical results, and deliver broader socio-economic and research impact across the policy lifecycle. Research dissemination and support activities include:

- · The weekly Geary Seminar Series;
- The Geary Institute Research Skills Initiative (GIRSI) – a series of free masterclasses focusing on specialist research tools, professional skills, and methods:
- The Institute's online policy analysis dissemination platform: PublicPolicy.ie;
- Interaction with the general public, scholars, and decision-makers via conferences, masterclasses, training sessions, seminars, and our working paper series.



KEY HIGHLIGHTS

EPEX

The Geary Institute for Public Policy has launched a new initiative called Empowering Policy Excellence (EPEx), which is intended to strengthen ties between policymakers, foster innovation in policy development, build research impact capacity, and provide educational programmes.

EPEx aims to enable policymakers to achieve excellence in policymaking, implementation and evaluation by: 1) Building stronger links between policymakers and UCD researchers to strengthen the evidence base for policy; 2) Enabling UCD researchers to maximise the policy impact of their research; and 3) Strengthening policymakers' capacity to commission, conduct, interpret and use research effectively to inform their work.

Under EPEx, there are currently four key initiatives under way at the Geary Institute:

- PublicPolicy.ie an online research dissemination platform
- A EPEx expert residency programme which allows industry professionals to spend three months at the Institute,
- A mobility programme to bring researchers from public policy institutes in universities abroad to UCD, and
- A webinar series for policymakers that will examine the latest innovations in thinking about formulating and implementing policy more effectively.

Bob Jordan, a key figure in Ireland's housing sector and former CEO of The Housing Agency, has joined the UCD Geary Institute for Public Policy as its first expert in residency.

As part of a new initiative aimed at strengthening ties between policymakers and fostering innovation in policy development, the Geary Institute has launched the Policy and Practice Expert Reflections (PAPERs) series. This programme allows industry professionals to spend three months at the Institute, offering insights into critical policy challenges they have encountered.

Open to individuals from Ireland's civil and public service, as well as relevant NGOs and commercial entities, the expert residency scheme provides an opportunity for policymakers and practitioners to produce a 5,000-10,000-word analysis on a significant policy or practical issue they have faced.


MEMBERSHIP

The Institute aims to balance relevance by providing solid facts to support policy decisions and discussions with excellence by publishing in prestigious international journals. The Institute currently has more than 142 researchers as members, and it accommodates more than 30 researchers (PIs, their teams, and related research guests) in addition to more than 50 doctoral students from various fields.

The UCD School of Sociology, UCD School of Chemistry, UCD School of Psychology, UCD School of Education, UCD Michael Smurfit Graduate Business School, and UCD School of Social Policy, Social Work, and Social Justice were among the new members appointed in 2024–2025.

In addition to actively participating in the Geary Institute Research Skills Initiative Masterclasses and weekly seminar series, members also contribute to the working paper series and the PublicPolicy.ie distribution platform. Through events and the Geary Institute weekly bulletin, the Directorate regularly interacts directly with members. Nine members are chosen from among the schools represented on the Institute's Executive Committee. To give direction on research priorities, funding streams, visiting and adjunct appointments, buildings and research infrastructure, etc., the Executive meets every two years.

WORKING PAPERS

Members can publish preliminary versions of their findings through the Institute's working paper series. The series' primary goals are to promote current scientific discoveries and disseminate knowledge.

The articles are available on the Institute's website and on Research articles in Economics (Ideas), a platform committed to disseminating economics and related social science research (www.repec.org).



As of 1 September 2024, the Institute's working paper series on www.repec.org had over 160,217 abstract views and 42,706 downloads.

RESEARCH FUNDING

During the 2024/25 academic year the following new research projects availed of office accommodation and project management support at the Geary Institute.

From Housing Inequality to Sustainable, Inclusive and Affordable Housing Solutions (Acronym: EqualHouse) was approved for funding under the Horizon Europe RIA call. The project is a pioneering research project funded by the EU that is set to revolutionise our understanding and approach to housing inequality. Prof. Michelle Norris, Director of the Geary Institute for Public Policy, is the PI for the project, and Dr Muireann Ní Rahallaigh, School of Social Policy, Social Work and Social Justice, is also a work package lead. This is a twelve-partner project with a total budget of €3.4 million, of which the UCD share is €650,000. The project commenced in January 2024. Ms. Emma Barron of Geary Institute for Public Policy manages the project.

Seasoned academics from a variety of European countries and disciplinary backgrounds, policymakers, affordable housing and homeless service providers are analysing the myriad aspects of housing inequality that have previously been studied in isolation. By doing so, we will provide comprehensive insights and robust guidance to policymakers at all levels across Europe.

The consortium kick-off meeting, held in Athens, Greece, on 7 April 2024, provided fruitful collaboration and plans for the future of the 48-month project.

RESEARCH CENTRES BASED AT GEARY

UCD Childhood and Human Development Research Centre (CHiLD-RC)

The CHilD-RC at UCD is a collaborative interface across the Bio-Psycho-Social Sciences that aims to enhance our understanding of children's well-being and human development by producing an integrated interdisciplinary knowledge base. Research on childhood and its consequences for life-course well-being has reached a point where collaborations between numerous disciplines are needed to produce ground-breaking research and inform policy.

The CHilD-RC aims to create a space for such collaborations to respond to important challenges and create insights into how early biological, psychological and social mechanisms affect life-course health and well-being. Through its research, the Centre aims to contribute to this knowledge base, which policymakers and practitioners can use to enhance child well-being. The Centre brings together UCD-based researchers who apply a range of quantitative, qualitative and mixed methodological approaches in researching all aspects of children's lives, from the early years to adulthood.

UCD Centre for Democracy Research

The Geary Institute also hosts the UCD Centre for Democracy Research (CDR), led by Dr Joseph Lacey of the School of Politics and International Relations. The Centre Democracy Research (CDR) is an interdisciplinary unit now based in the School of Politics and International Relations, University College Dublin.

The main purpose of the Centre is to a) foster connections between researchers working on democracy across the university, b) enhance the visibility of the work being carried out by democracy scholars at UCD, and c) engage the public on current debates that are central to democracy in Ireland, Europe and the wider world.

UCD Behavioural Science and Policy Group

The behavioural science and policy group is a research and collaboration centre focused on incorporating behaviourally informed concepts into public policy. Dr. Vessela Daskalova leads the group. The research team is made up of a core group of faculty, researchers, and PhD students, as well as a diverse network of research affiliates and other stakeholders.

The Centre's goals are to make a significant contribution to the international growth of behavioural science and to serve as a vital venue for the field's integration into public policy. The Centre conducts research on the following subjects using techniques like surveys, economic theory, secondary data analysis, and lab and field experiments:

- Psychological determinants of decision-making (e.g. self-image and identity, social image, emotions, self-control)
- Subjective well-being
- · Economics and mental health
- Ethical uses of behavioural insights
- Administrative burden and 'Sludge'
- · Political behaviour and preferences
- Discrimination
- Online social influence



UCD Ageing Network

UCD Ageing Network focuses on interdisciplinary collaboration and emphasises the value of ageing research, bringing together researchers from various fields, including medicine, physiotherapy, psychology, dietetics, public health, and more. UCD Ageing Network, with the help of the Geary Institute, is working on gaining more visibility online and is planning exciting workshops and events in the coming term.

Their mission is to harness inter- and transdisciplinary intellectual capital, creativity and curiosity to create optimum environments (political, social, physical, health, and technological) that enable older people to age well within their communities and contribute to a just and fair society.

Dr Sarah Donnelly, Associate Professor in Social Work at UCD School of Social Policy, Social Work and Social Justice, leads the project.

Democracy Challenged

Democracy Challenged is a 5 year project funded by the European Research Council (ERC) to investigate the role of legal-technical power in shaping corporate tax avoidance and the wealth inequalities that undermine democracy.

Prof Aidan Regan's ERC-funded Democracy Challenged project focuses on corporate tax avoidance as a catalyst for inequality. It employs innovative methods like forensic accounting and survey experiments. Through empirical analysis, the project shows how global capital circumvents democratic fiscal checks. Divided into four work packages, it unravels the intricate web of big tech and pharma's tax avoidance strategies. By dissecting legal-technical mechanisms and media narratives, the project aims to disrupt wealth protection strategies.

The Geary Institute welcomed the project in 2024.



UCD Centre for the Advancement of Wellbeing in Education

Led by Dr Seaneen Sloan (UCD School of Education), the Centre for the Advancement of Wellbeing in Education is an interdisciplinary hub for wellbeing research, intervention development, and education. It is unique within UCD and Ireland, adding value by focusing on wellbeing across the lifespan and channeling UCD's expertise to play a leading role in addressing wellbeing as a major global issue.

In particular, the participants reflected on the self-completion of the ESS12 pilot in Ireland and its implications for methods, response rates, timelines, and costs. Dr Collins then invited the guests to lunch.

The event was part of the European Social Survey (ESS) Round 11 National Coordination Activities based at the UCD Geary Institute for Public Policy. The ESS will become a self-completion survey from Round 12 onwards.

Work-Life Balance Policy Making in Ireland

The Geary Institute for Public Policy hosted an event on Work-Life Balance Policy Making in Ireland on October 15 at MoLI. The event featured a presentation by Ieva Zumbyte (Geary Fellow) on Ireland's compliance with the EU Work-Life Balance Directive, followed by a panel discussion. The panel included Pauline Cullen (Associate Professor of Sociology, Maynooth University), Alice-Mary Higgins (Senator, Seanad Éireann), Laura Bambrick (Head of Social Policy & Employment Affairs, ICTU), and Donal Swan (Women's Economic Equality Coordinator, NWC), with moderation by Dorota Szelewa (Geary Fellow). The discussion explored key issues related to care, gender, and work in Ireland. A key takeaway from the roundtable was the need to shift the perception of care policies from being seen as concessions or obstacles to economic competitiveness, to recognizing and valuing care as a cornerstone of societal prosperity.

Using Algorithms to Detect Gerrymandering and Improve Legislative Redistricting: Cases from the United States and Japan

On 5th November 2024, the Geary Institute hosted an insightful event titled **Using Algorithms to Detect Gerrymandering and Improve Legislative Redistricting: Cases from the United States and Japan** at the Old Physics Theatre, Museum of Literature Ireland. The event, which drew attention to the critical role of legislative redistricting in ensuring fair representation in democracies, explored how computational algorithms and granular data can be used to detect gerrymandering and evaluate partisan bias in redistricting. The speaker, drawing from first hand involvement in U.S. redistricting court cases, also compared the use of these algorithms in Japan, where political influence over redistricting is less pronounced.

The discussion provided a deep dive into the intersection of technology, politics, and democratic processes.

Policy and Political Responses to Ireland's Refugee Crisis

On 27th November, Professor Bryan Fanning from University College Dublin presented a seminar titled Policy and Political Responses to Ireland's Refugee Crisis. The discussion explored Ireland's evolving policies on refugee protection, political discourse surrounding migration, and the challenges of integration. Professor Fanning examined government responses, public attitudes, and the broader social implications of the crisis. The seminar provided critical insights into the intersection of migration policy and politics, highlighting key issues shaping Ireland's approach to refugees and asylum seekers.

A 'proper' woman? One woman's story of success and failure in academia

On 21st November 2024 Professor Pat O'Connor, Professor Emeritus of Social Policy at the University of Limerick and Adjunct Senior Research Fellow at the Geary Institute presented a seminar on her recently published book, A 'proper' woman? One woman's story of success and failure in academia. Her lecture explored the gendered challenges women face in academia, offering critical insights into structural inequalities and personal resilience. The lecture was hosted jointly by the Geary Institute for Public Policy and the UCD Centre for Gender, Feminisms and Sexualities.

The Costs of Uncertainty: Towards a New Paradigm

On February 12th, the Geary Institute Seminar Room hosted a thought-provoking seminar titled "The Costs of Uncertainty: Towards a New Paradigm." The speaker, Professor Claire A. Hill, James L. Krusemark Chair in Law at the University of Minnesota and Visiting Professor at UCD School of Law, explored the distinction between risk and uncertainty in legal and financial contexts. Drawing on her research and industry experience, she examined how uncertainty influences decision-making, with particular reference to financial markets and the 2008 crisis. The seminar, jointly hosted by the Geary Institute and the BSP Group, provided a compelling discussion on the implications of uncertainty in law and policy.

Education for All? Literature, Culture and Education Development in Britain and Denmark

On February 20th, a thought-provoking seminar titled "Education for All? Literature, Culture and Education Development in Britain and Denmark" was held in the Geary Institute Seminar Room. The event featured Cathie Jo Martin, Professor Emerita of Political Science at Boston University, as the speaker, and Stefan Müller, Associate Professor of Political Science at UCD, as the discussant.

Organised by the School of Social Policy, Social Work and Social Justice and supported by the Geary Institute, the seminar explored why Denmark established mass education for all in 1814, while Britain delayed a public-school system until 1870, focused mainly on academic achievers. Drawing from a multidisciplinary perspective, Martin argued that nineteenth-century literary narratives played a crucial role in shaping education policies, with Danish writers portraying mass education as essential for societal and economic growth, while British authors often depicted it as a potential threat to social stability and national culture.

Making Rental Housing Affordable: International Perspectives Webinar Series

This topical webinar series was organized by Dr. Michael Byrne and Dr. Sarah Sheridan, drawing on international experts to address some of the most pressing challenges facing the Irish housing system.

The series was funded by the Housing Agency and the College of Social Sciences and Law, and supported and hosted by the Geary Institute. With five webinars running between March and June 2025, the webinars looked at housing acquisition in the UK, Cost Rental housing in Austria and Denmark, and rent regulation in Spain and Germany. Average attendance across the webinars was 55 participants. Participants included many staff at key agencies involved in policy making, including the Department of Housing, the Housing Agency, Local Authorities, and members of the Oireachtas.

All webinars were recorded and have been made available online, and so far have generated almost 5,000 views.

UCD Ageing Network Meeting

On Thursday, 20th March, members of the UCD Ageing Network, coordinated by Dr Sarah Donnelly from the UCD School of Social Policy, Social Work, and Social Justice, gathered at the Geary Institute for Public Policy for a productive planning meeting.

This gathering provided an invaluable opportunity to discuss future research directions, collaborations, and initiatives to strengthen our collective efforts in the field of ageing studies.

Writing Retreats

'Interdisciplinary Writing Solidarity Group' (IWSG) project was launched in March 2025. This is a joint initiative between the Geary Institute for Public Policy (Dr Laura Foley) and the School of Psychology (Dr Glen Jankowski, Pat Mulvaney, and Isabelle Nic Craith) that is funded by UCD ReCLAIM fund.

At the core of the IWSG is the idea that working alongside others in a supportive, distraction-free environment provides an opportunity to advance progress on journal articles, PhD chapters, conference papers/abstracts, and funding proposals.

The programme of events for 2024/25 included 13 writing retreats and three workshops.

PUBLICPOLICY.IE

PublicPolicy.ie is an online platform for informing academic and contemporary debates about public policy in Ireland. Established in 2012 with support from Atlantic Philanthropies, it was incorporated into the Geary Institute for Public Policy in 2019. The aim of the PublicPolicy website is to provide independent evidence to inform economic, social and environmental policies by communicating policy-related research findings and information in an accessible way to policymakers, non-specialist academics and members of the public. The platform is independent, has no party-political association or view, and is not aligned with any sectional interest.

The online platform is a resource for research and information which is disseminated in two main ways. First, it highlights key policy-relevant reports that have been published externally, through the website's 'External Reports' function. Between July 2024 and July 2025, 61 External Reports were featured on the website.

Second, it disseminates original research papers that have been written in a clear, accessible way for non-specialist audiences and which cover an array of policy-related issues. Between July 2024 and July 2025, 42 papers were published on the website. Most of these papers focused on one (or more) of the following areas: health, education, the environment, AI, and housing.



Since January 2022, Dr Laura Foley, Postdoctoral Research Fellow at the Geary Institute, has been managing the content on PublicPolicy.ie.

From July 2024 - July 2025, the website had over 75,000 views. The top five viewed papers were:

- Data Centres in Ireland (4,551)
- Gender-Based Violence in Ireland (4,092)
- Equity in Teacher's Pay: Will new entrants ever catch up? (2,705)


ACTIVITIES

Place-based indicators for Well-being Project (Dept of Community and Rural Development & Dept of An Taoiseach)

Professor Niamh Moore-Cherry was invited to be the only independent / non-government department expert on the steering group. The research project aimed to scope the availability and conceptualization of local level data and identify potential indicators which bridge rural and community development policy level indicators with the national Government of Ireland Well-being Framework. The project ran from July 2024-March 2025.

Ministerial Action plan on Planning resources (Dept of Housing and Planning)

The Ministerial Action Plan on Planning Resources focuses on the requirements of local government and the public sector generally and is aimed at ensuring that there is a sustainable pipeline of planning and related expertise to address resourcing needs over the short, medium and longer-term. A Steering Group has been established for the purposes of coordination and oversight of action plan development and implementation including representation from the local government sector, An Bord Pleanála, The Office of the Planning Regulator (OPR), the Department and DFHERIS. Professor Niamh Moore-Cherry has been invited to serve as a 3rd level representative member of the Steering Group.

Planning for the Next Disaster : A Data-Driven Approach for Policy Evaluation with an Application to COVID-19

Geary Fellow, Dr Alessia Paccagnini was the invited Speaker at IFS 2025 – Planning for the Next Disaster: A Data-Driven Approach for Policy Evaluation with an Application to COVID-19 (joint with Annunziata Esposito Amideo, UCD and Luca Pistilli, UCD). The event took place from 29th June and 2nd July in Beijing, China.

The event stimulated high-level discussion on integrating high dimensionality techniques with policy evaluation frameworks; demonstrated the practical relevance of combining optimization and econometrics in crisis response. The work attracted interest from policy institutions exploring preparedness strategies for future systemic shocks.

IAAE 2025

The IAAE 2025 - Dealing with the Statistical Representation of DSGE Models took place from 25th to 27th June 2025 at the University of Turin, Italy. The Land Use Review Phase 2

The Land Use Review Phase 2 is a government initiative to identify the key demands on land (both public and private) to inform policies for land use across key government objectives, improving socioeconomic, climate, biodiversity, water, and air quality outcomes. The Review ran from October 2023 to April 2025.

The Review was directed by an Oversight Group, which reports to the Minister for the Environment, Climate and Communications; the Minister for Agriculture, Food and the Marine; and the Minister of State for Heritage and Electoral Reform. The Oversight Group was chaired by Geraldine Tallon, retired Secretary General of the Department of the Environment. Other members included Prof Mark Scott, Professor of Planning and Dean of Architecture, Landscape Architecture, Planning and Environmental Policy in UCD, Prof Rory O'Donnell, retired Director of NESC and a Fellow of the Geary Institute, and representatives of the three government departments. The work of the Oversight Group was supported by a Technical Working Group, chaired by Prof Scott and a Citizens Engagement Group, chaired by Prof O'Donnell.

The final report, A Living Land: Report of Phase Two of the Land Use Review, was submitted to the three ministers on 30th April 2025.

UACES 55th Annual Conference

During the UACES 55th Annual Conference that took place in Liverpool between the 31st August and 2rd September, the chair of the UACES, Toni Haastrup, had the pleasure of presenting the 2025 winners with their awards, recognising their exceptional contributions to European studies. The best book award went to Politicising Commodification - European Governance and Labour Politics from the Financial Crisis to the Covid Emergency, by Geary Fellow, Roland Enre, Sabina Stan, Darragh Golden, Imre Szabó and Vincenzo Maccarrone

UCD Ageing Network Launch Event

On 25 June 2025, the UCD Ageing Network supported by the Geary Institute for Public Policy was officially launched with an event attended by many distinguished guests. The vision of the UCD Ageing Network is to contribute to an age-attuned world and to prepare for the economic and social shifts associated with population ageing in Irish Society and globally.

Network Coordinator Assoc. Prof Sarah Donnelly, from UCD School of Social Policy, Social Work and Social Justice, delivered the opening remarks, joined by Prof Michelle Norris, Director of the UCD Geary Institute for Public Policy, who warmly welcomed all attendees. The event brought together researchers, educators, professionals, academic partners, civil society actors, and third-sector organisations representing older people. Our key presentations included Dr Nat O'Connor, who gave a talk on responding to ageing populations, followed by presentations from Dr Carmel Davies and Assoc Prof Sarah Donnelly on the importance of Patient and Public Involvement in ageing research.

Other members of the UCD Ageing Network also shared their current projects and research, showcasing the range and diversity of expertise across the university. These included Assoc. A special moment was the launch of the UCD Age Well Podcast, introduced via a recorded message from Olayinka O. Aremu, Lecturer and Assistant Professor in General Nursing at the UCD School of Nursing, Midwifery and Health Systems, its founder and host, who was unable to attend in person.

The meeting included representatives from the Irish Senior Citizens Parliament, Active Retirement Ireland, ALONE, the Patient Advocacy Service, Age Action Ireland, Our Lady's Hospice & Care Services, Care Alliance Ireland, and Care Champions. Their attendance highlighted the network's collaborative and inclusive vision.

BSP Workshop on Research Culture

On the 30th April 2025 the BSP Group hosted the first workshop from the series "Supporting a Positive Research Culture in Experimentation" funded by a UCD Research Culture ReCLAIM award. The workshop was organised by members of the BSP Group consisting of Diogo Geraldes, Margaret Samahita, Oana Peia, Marta Talevi, Yung-Shiang (Jasmine) Yang, Sinéad Flannery, Oscar Barrera-Rodríguez and Vessela Daskalova.

Experimentation is a crucial tool for research and collecting causal evidence in various fields such as economics, psychology, environmental science, agriculture, biology, medicine, and many others. Recent concerns about the trustworthiness and replicability of findings in various fields have highlighted that how we do experiments matters.

The goal of this proposal was to establish a positive and reflective research culture around experimentation. There are experts across different Schools in UCD for whom experimentation is an important part of research. However, we do not necessarily know much about the best practices of experimental researchers in other disciplines and often also of researchers using different types of experiments within a discipline (laboratory, field, online).

The group started a bottom-up discussion from an interdisciplinary aroup of researchers experimentation in order to support each other and learn from our experiences. The format was through a series of 3 workshops in which they discussed best practices for experimental research. The first two workshops were UCD internal, the third one featured invited speakers from abroad who are key figures from different disciplines in this debate. A positive and reflective research culture raised questions around the role of pre-registration, replication, publication biases, ethics, pilot experiments, incentivization in experiments, interpretation of findings, reacting to challenges and learning from failures. A key objective of the proposal was to develop a positive and nurturing research environment for the next generation of researchers.

Staff shortages in the social and healthcare sector: Europe's business too!

Geary Fellow, Prof Roland Erne was invited to give a talk together with Sabina Stan on EU Governance Interventions & Healthcare: Working Conditions & Staff Shortages. EU Competences, EU Crisis Interventions and Future Developments at the conference 'Staff shortages in the social and healthcare sector: Europe's business too!' in the European Parliament, organised by the European Network: 'Our Health is not for sale' and the European Public Service Union (EPSU).

The event took place on 7th April 2025 at the European Parliament, Brussels.

Canadian Institute for Advanced Research Award

Dr Boróka Bó, an Assistant Professor of Sociology at the UCD School of Sociology, was awarded funding from the Canadian Institute for Advanced Research (CIFAR). Dr Bó specifically received the 'CIFAR Azrieli Global Scholar in CIFAR's Innovation, Equity & The Future of Prosperity program' award, which will be administered by the Geary Institute with Emma Barron as project manager. The award is CAN\$ 100,000.

Constitutional visions from the grassroots: crossborder and cross community deliberation

Between September 2024 and November 2025, Geary Fellow, Prof Jennifer Todd worked in the project 'Constitutional visions from the grassroots: cross-border and cross community deliberation', funded by DFAT Reconciliation Fund (July 2024) and the University of Notre Dame, Keogh Naughton Institute, ARINS (August 2024). The project had as co-investigators, Prof Joanne McEvoy, University of Aberdeen and Dr Shelley Deane, DCU.

The project's interim was presented to the Councils, to the Joint Oireachtas Committee on the Implementation of the Good Friday Agreement, and to politicians with further dissemination events in MidUlster in September and a final report launch schedule for November 2025. The work was reported in local and national newspapers, including The Irish Times.



Preparing for Life at 14

Led by Geary Fellow, Prof Orla Doyle, the Preparing for Life 14 study has its results launched on 23rd May 2025.

The PFL research has had a direct impact on Government policy and spending. It is included in 'First 5: A Whole-of-Government Strategy for Babies, Young Children and their Families' and contributed to the investment of >EUR40M in Area-Based Childhood (ABC) Programmes and the Prevention, Partnership & Family Support Programme. In 2022, the ABC programmes, including PFL, worked with 10,127 parents and 27,274 children. These impacts were achieved by engaging with Government ministers and policymakers via policy events and policy briefs, as well as PFL's involvement in the Home Visiting which has been credited for the Government's decision to expand home visiting services and develop the National Home Visiting Programme. Monitoring the roll-out of this national initiative will demonstrate the long-term reach of this research.

The PFL findings have led to its expansion to 10 other Irish communities serving >450 families in Bray, Athy, Newbridge, Balbriggan, Finglas, Ballinasloe, Bagenalstown, Kilrush, Castlebar, Ballaghaderreen. PFL's research has also received international recognition. The US Department of Health & Human Services officially recognised PFL by including it in the "Home Visiting Evidence of Effectiveness" list based on a review of PFL studies conducted by Professor Doyle. It is the only Irish programme eligible for US federal and state funding. In partnership with Nobel Laureate, Professor James Heckman, a second PFL study, called Creciendo Juntos, began in 2023. Working with the local community in Chicago, PFL has been culturally and socially adapted to serve 250 Latino families.

Labour Politics and the EU's New Economic Governance Regime

In collaboration with the Geary Institute, the ERC project hosted the final conference of their project "Labour Politics and the EU's New Economic Governance Regime" on the 5th September 2025, in the Royal Irish Academy in Dublin, Ireland, including a book discussion of Politicising Commodification-European Governance and Labour Politics from the Financial Crisis to the Covid Emergency.

The invited critics included Andreas Bieler (Nottingham, UK), Claire Kilpatrick (EUI Florence, Italy), Esther Lynch (General Secretary, ETUC, Brussels), and Angela Wigger (RU Nijmegen, Netherlands). The Director of the UCD Geary Institute for Public Policy, Prof Michelle Norris, facilitated the discussion with Esther Lynch.

CONUNDRUM Project

The CONUNDRUM project funded by Research Ireland through the Sustainable Communities National Challenge Fund, aims to understand mobility issues in Irish towns and to reimagine how we could achieve more sustainable transport and mobility outside of our cities. Our purpose is to support more resilient urban areas and sustainable communities by enabling government, citizens and enterprise to work more effectively together. For communities without significant public transport infrastructure or financial resources to upgrade to private electric vehicles, a push to decarbonise mobility has the potential to further marginalise our most vulnerable groups particularly in smaller towns with less developed infrastructure. As such, while decarbonisation may be ultimate policy objective, achieving just the transitions to more sustainable mobility is key to meeting wide-spanning policy goals.

The project is managed by Geary Fellow, Prof Niahm Moore-Cherry, Dr Dean Phelan, Dr Rachel McArdle, Dr Kieran Harrahill and Mr Zikang Ji (UCD) and Prof Brian Caulfield, Dr Abhilash Singh, Dr Conor Mark Dowling (TCD) and has successfully completed the Concept and Seed phase of funding in February 2024 and was one of only 5 projects that successfully progressed to the Grow phase. The project team are now working in two more towns to develop the process and tools as they compete for the Prize phase of the Challenge. A key output was the Enniscorthy Community-led mobility strategy launched in November 2024, and 6 of the 9 actions identified are now underway by various stakeholders.

The team have supported Local Link with a survey to provide the evidence base for a new town bus service, have been invited to present to the Department of Transport Sustainable Mobility team, and will be featured in the 10 Things to Know About TV series to air this autumn.

To accommodate the increased number of PhD space applicants, the Institute added an extra office to give additional desk space, as well as an open plan space for 50 PhD students. Desk space applications are accepted each summer for the upcoming school year. The PhD students run a regular seminar.

BICS (Building International Collaboration Supports) seed funding Scheme

Our seed funding program, BICS, or "The Building International Collaborations Supports," led to a number of foreign partners visiting us for exchanges. The BICS program was created to encourage publications, research funding applications, and international collaborations.
