(One Year Full-Time or Two Years Part-time)



## Introduction

This programme offers a genuinely interdisciplinary approach to European legal studies. Graduates gain an enhanced understanding of how law and politics shape the European Union, and the skills required to analyse and predict the future development of this unique polity. The LLM programme requires at least one module in political science to ensure a broad understanding of the EU.

Faculty at UCD Sutherland School of Law and across the university have strong profiles in researching the EU, its law and politics and

impact on societies. Specialisations comprise the EU's institutional structure, rule of law, human rights, environmental law and policy, EU and social justice, migration, competition law, economic freedoms and economic and monetary union.

The programme is ideal for graduates in law and cognate disciplines, including political science, sociology and European studies, and also offers those already in employment the opportunity to gain intellectual inspiration and enhance their career.

## Applicant Profile

- This programme is intended for applicants with a Law degree, or an interdisciplinary degree in which law was a major component. An upper second class honours, or international equivalent is required.
- Applicants holding a Graduate Diploma in Law can be considered.
- Exemption may be given to those with significant, relevant, practical experience or those with a relevant graduate qualification.
- Applicants whose first language is not English must also demonstrate English language proficiency of IELTS 6.5 (no band less than 6.0 and 6.5 or above in reading and writing), or equivalent.
