of topics in the field of criminology and criminal justice, including work on coercive confinement, prison violence and desistance from crime.

Entry Requirements

- This programme is intended for applicants with an honours degree in any discipline. An upper second class honours, or international equivalent is required.
- Exemption may be given to those with significant and relevant, practical experience or those with a relevant graduate qualification.
- Applicants whose first language is not English must also demonstrate English language proficiency of IELTS 6.5 (no band less than 6.0 and 6.5 in reading and writing), or equivalent.
