Purpose

The Student Feedback system has been reviewed, the first review since its introduction in 2012. Following a university-wide consultation during 2019, there was general agreement that:

- the questionnaire content was to be updated
- the current system should be changed
 - o to reflect the need to increase student response rates
 - to provide feedback to students
 - o to allow faculty to have their individual teaching contribution captured for the purposes of their development and the promotion system.

The purpose of this proposed project is to provide a new system with the appropriate functionality to enable the feedback loop to students to be closed and to allow schools to gain deeper insights into their students' perceptions of their learning.

This is with a view to having a reliable, secure and fit for purpose student feedback system at an enterprise level. Following the Covid 19 remote teaching period the need for student feedback and opportunity for two-way engagement with our students is evident and more critical than ever before.

- Agree on a solution that best meets the requirements of the University in relation to student feedback for teaching and learning activities
- Assist and oversee the change management and promotion of technology in relation to student feedback.
- Ensure that due diligence is carried out in relation to legal, data protection and accessibility requirements.
- Provide project updates to the University Teaching & Learning Committee and reporting to the Acting Registrar or a nominated group e.g. UMT Education Group, UMT Services Group.
