Demobilizing Empires: The Transition from War to 'Peace' after the Great War

This symposium will seek to provide a global perspective on the often violent (and sometimes peaceful) paths of transition from war to 'peace' in the years following the First World War in both the formal and informal territories of the 'blue-water' imperial powers.

In this exploratory workshop we will bring together scholars to examine the seeds of decolonization and patterns of demobilization and remobilization in the European and Asian empires in the aftermath of the First World War. Through comparative discussion and debate organized in themed subject panels, this workshop will work towards a transnational understanding of the origins, nature and consequences of war imperialism, anti-colonial resistance, religious and communal unrest, and imperial policing and paramilitary violence in the extra European world.
